RIDER FOR SABRE SYSTEMS PRODUCTS AND SERVICES

1. <u>Scope; Definitions</u>. These terms apply to the **Sabre Systems** services and associated Software (together the "Service" or "Services"). If the above-referenced Agreement was previously cancelled, has expired, was not previously committed to writing, or is determined to have been lost or destroyed, it is understood and agreed that Johnson Controls' Standard Terms and Conditions posted at <u>www.tycois.com/standardtandc</u> are incorporated herein by reference and together with the terms of this Rider shall apply to the Services. The term of the Agreement shall be extended and shall continue to apply while the Services are being furnished. Johnson Controls agrees to provide the Services subject to Customer's acceptance of the terms and conditions contained herein. All terms not specifically defined in this Rider shall have the meanings ascribed to them in the Agreement. If a conflict or inconsistency exists between the terms and conditions of the Agreement and this Rider, then the terms and conditions of this Rider shall prevail, except that in no event will this Rider increase Johnson Controls' liability under the Agreement.

2. Availability in Canada. In Canada, the is not available in the Province of Québec.

3. <u>Software</u>. If you purchase security awareness training services as part of the Services, you agree to comply with the terms and conditions of the InfoSec Institute SecurityIQ License Agreement ("License Agreement") sublicensed to Sabre Systems, Inc. and Johnson Controls and which can be found here: https://securityiq.infosecinstitute.com/Users/tos. The terms "You" and "Your" refer to "Customer." Executing this rider and use of the security awareness training service confirms Your agreement with the terms and conditions of the License Agreement. The InfoSec Institute, Sabre Systems, Inc., and Johnson Controls reserve the right to modify or update the License Agreement for the security awareness training at any time.

4. <u>Term; Termination</u>. The Service will be provided for an initial term as stipulated in the Agreement (the "Initial Term") and thereafter will automatically renew on an annual basis unless sooner terminated by either party. Notwithstanding the foregoing, in the event the Agreement expires or is terminated prior to expiration of the Initial Term, this Rider will also expire/terminate. In addition to any other remedies available to Johnson Controls, Johnson Controls may terminate this Rider and discontinue any Services if (a) Johnson Controls is unable to obtain any connections or privileges required to provide the Services, (b) Customer's failure to follow the operating instructions provided by Johnson Controls results in an undue number of service calls; (c) in Johnson Controls' sole opinion, the environment in which the Services are provided is unstable, unsuitable, or so modified or altered after installation as to render continuation of the Service impractical or impossible; (d) Johnson Controls is unable to obtain or continue to support technologies, communication facilities, system or component parts thereof that are discontinued, become obsolete or are otherwise not commercially available to Johnson Controls; or (e) Customer fails to make payments when due or otherwise breaches this Rider or the Agreement. Johnson Controls will not be held to be in breach of the Agreement or otherwise be liable for any damages or subject to any penalty as a result of any such termination.

5. <u>Service Fees</u>. During the Initial Term, Johnson Controls shall sell the Services to Customer at the Service Fees set forth in the Agreement. After the Initial Term, any Service Fee increase shall be subject to the mutual agreement of the parties.

6. <u>Technical Support</u>. Johnson Controls will provide technical support to You as part of the Service Fee. You may request technical support by calling: 833-524 -7227 (833-JCI- SABRE) 8am-5pm EST, Monday through Friday, excluding federal holidays.

7. <u>Use of the Service</u>. Customer is solely responsible for the information, material, or content transmitted in connection with the Service, and Customer has full responsibility for such content, including but not limited to legality, reliability, appropriateness, originality, and copyright. Johnson Controls or Owner may revoke Customer's or any authorized user's access to or right to use the Service if Johnson Controls or Owner finds, in their collective or individual sole judgment, that Customer, or any Customer employees, agents, or assigns have breached any provision of the Agreement. The Service is provided "AS IS" and without warranties of any kind either expressed or implied, to the fullest extent permissible pursuant to applicable law, Johnson Controls and Owner disclaim all warranties or merchantability and fitness for a particular purpose. Neither Johnson Controls nor Owner warrant that the Service will be uninterrupted or error-free, or that defects will be corrected, or that the website or the server that makes the Service available are free of viruses or other harmful components. Johnson Controls and/or Owner may however make revisions and/or upgrades to the Service at their discretion and make them available to Customer.

8. <u>Data Hosting/Storage Services</u>. Customer understands that, in connection with Johnson Controls' provision of the Services, Johnson Control and/or its agents, suppliers, or subcontractors, may receive, transmit, record, store, and/or provide unencrypted data, audio, and/or images ("Data") from/to Customer via the Internet and/or store such Data in off-site third party facilities, and such Data may include information about Customer's personnel, assets and/or premises. Customer represents and warrants that Customer has obtained all consents and has the right to (a) disclose to Johnson Controls all personal information that may be disclosed hereunder concerning individuals/employees/or other third parties; (b) collect (including consent to record telephone conversations with Johnson Controls), use, disclose and transfer such personal information; and (c) authorizes Johnson Controls to use such personal information to administer the relationship between Customer and Johnson Controls, including the administration of this Agreement. Customer acknowledges and agrees that Johnson Controls may share all such information with its parents, subsidiaries, affiliates, suppliers and its/their successor corporations or any subcontractor or assignee, within and outside the country in which the Customer is located and thereby subject such information to the laws of such countries.

10. <u>Disclaimer of Warranties</u>.
